



## Regulations Prix Galien Pharmaceutical Award 2020

The **Prix Galien Pharmaceutical Award**, consisting of a gold medal, rewards the most meaningful and/or innovative medicine for human use.

### Article 1

The **Prix Galien Pharmaceutical Award 2020** rewards the most meaningful and/or innovative medicine for human use that was marketed in the Netherlands between January 1<sup>st</sup> 2019 and December 31<sup>st</sup> 2019. It must have a Dutch or European marketing authorisation (EMA) not older than three years before the introduction.

### Article 2

The registration can be made online from the 15<sup>th</sup> of December until the 13<sup>th</sup> of March 2020 through [www.prixgalien.nl](http://www.prixgalien.nl) (Registration Prix Galien Pharmaceutical Award 2020);

1. The dossier on the product proposed for the Award consists of a maximum of fifteen (15) A4 pages;
2. This dossier must contain at least the following elements:
  - a motivation in which the applicant states why the product is eligible for the Prix Galien Pharmaceutical Award (innovative/meaningful);
  - the 'EPAR summary for the public' containing a link to the underlying EPAR file;
  - additional information relating to preclinical and clinical evaluation to the extent not presented in the EPAR;
  - relevant publications to the extent not included in the other paragraphs.
3. The file must be sent by e-mail to [philip.delorme@prixgalien.nl](mailto:philip.delorme@prixgalien.nl) as one PDF by **15<sup>th</sup> of May 2020**, with the entry 'Candidate Prix Galien Pharmaceutical Award 2020'
4. Only digital files will be accepted.

### Article 3

Applying for the Prix Galien Pharmaceutical Award 2020 also means participating in the composition of the Prix Galien Magazine 2020. It consists of an editorial page including image and logo of the product submitted. The costs of candidacy for the Prix Galien Pharmaceutical Award is € 4,950 excl. VAT and also give access to the award ceremony including dinner for 4 guests. The applicants are also expected to deliver a short product video of up to 1.5 minutes which will be shown at the award ceremony.

### Article 4

The winner of the Prix Galien Pharmaceutical Award 2020 is also eligible for the competition of the International Prix Galien which will be awarded biannually (in 2020).

### Article 5

The judging takes place by the jury of the Prix Galien Research Award and Prix Galien Pharmaceutical Award.

### Article 6

The jury's decisions are irrevocable.

### Article 7

The result regarding the nomination of the candidates and winner of the Prix Galien Pharmaceutical Award 2020 will be announced during the award ceremony itself. It is not possible to correspond about the results.
